I agree that I will not sell, give away or otherwise dispose of said animal to any person(s), dealer, retailer, auction, institute, or any other entity for any reason. If at a later date I am unable or unwilling to keep this pet, I agree to first contact the above-described current owner and give them the option to reclaim said pet at no charge.

I hereby agree to care for the above-described pet in a humane and responsible manner and to provide it with clean and adequate shelter, food, water and veterinary care. I further agree that said pet shall reside inside my home and shall not be allowed to roam freely. I hereby agree that this pet shall always wear a collar or harness with identification tags. I hereby agree that the adoption donation of \$ _____ helps to cover the shelter's expense of raising and caring for the animal and is not refundable. I hereby understand and agree that the shelter makes no representations or warranties, expressed or implied, about the above-mentioned animal's temperament, behavior or health issues and is hereby absolved from any liability for future damages or injuries caused by said animal. I also understand and agree that the shelter further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his family. I understand That I am adopting a rescue animal and will not hold Little Rescue on the Prairie liable for health or behavior issues.

I understand that my home is a new environment and that the animal may need time to adjust. There may be shyness, hiding, aggression, sickness (including throwing up) lack of appetite etc. that may occur.

I understand that any and all donations and fees are non-refundable and there is no guarantee of pet's health or behavior Expressed, written, or implied.

If for any reason, I do not wish to keep my pet I promise to return the pet back to Little Rescue on the Prairie. I certify that all statements made by me on this adoption agreement are true and correct. I agree that the current owner has the right to confiscate the above-described animal in the event that any statements made by me are found to be false and/or my check for the adoption fee is returned for insufficient funds.
